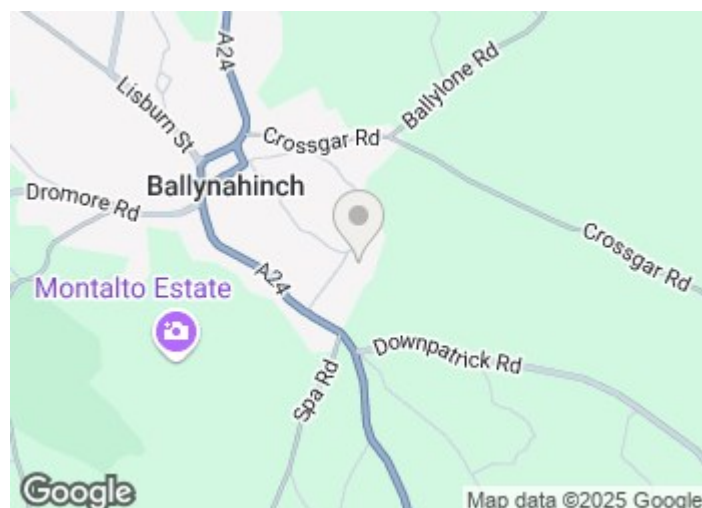

To the front is a tarmac driveway with ample parking, gardens laid out in lawns and mature plantings. To the rear is a large garden with lawns, patio area and decking.



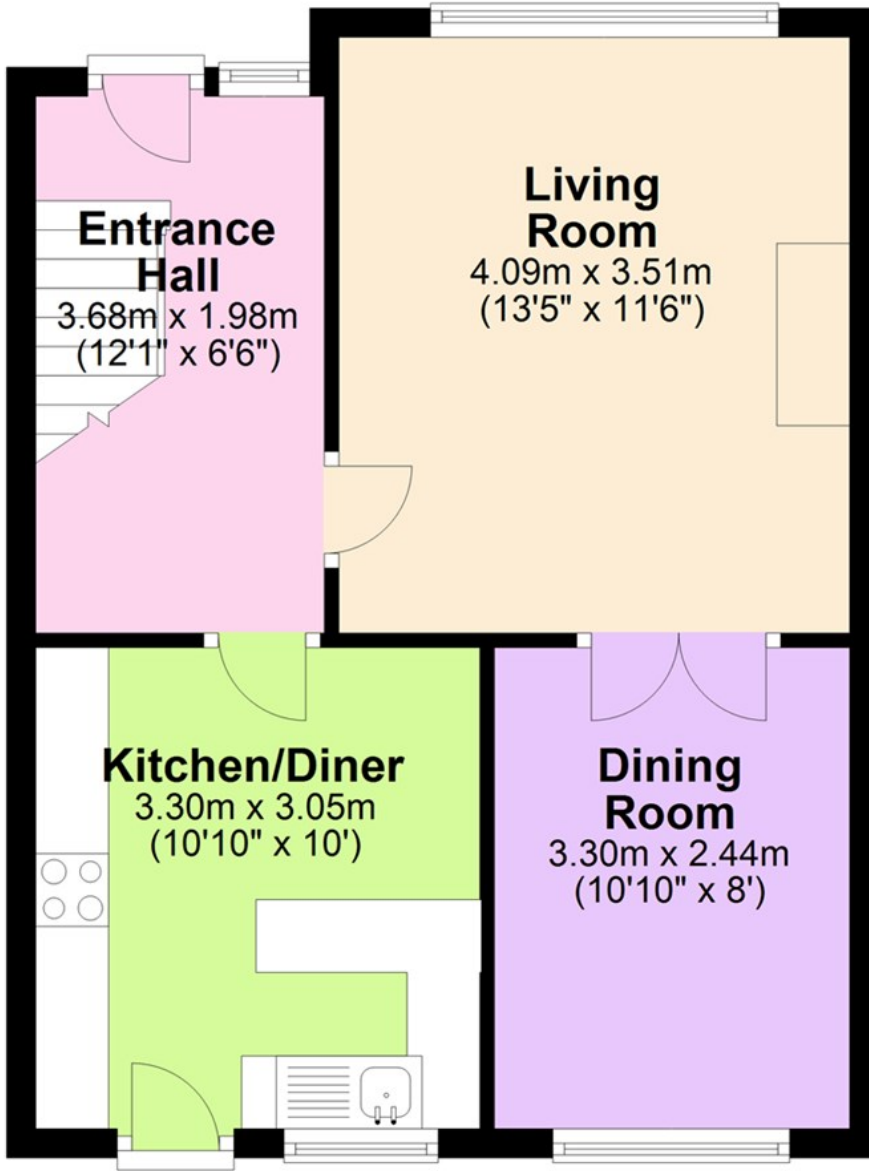

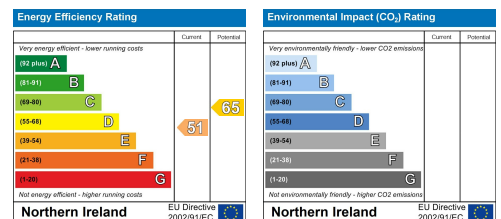


## Floor Plan
